TRADE-MARK FOR STOVES AND RANGES.

STATEMENT and DECLARATION of Trade-Mark No. 23,886, registered November 28, 1893.

Application filed October 18, 1893.

STATEMENT.

To all whom it may concern:

Be it known that THE FAVORITE STOVE AND RANGE COMPANY, a corporation organized under the laws of Kentucky, having its principal place of business at Piqua, in the county of Miami, State of Ohio, has adopted for its use a Trade-Mark for Stoves and Ranges, of which the following is a full, clear, and exact specification.

The trade-mark of said company consists of the word-symbol "Favorite;" this has generally been arranged as shown in the accompanying fac-simile, above the words "Stoves and Ranges," and the said word-symbol together

This trade-mark was registered in the United States Patent Office by W. C. Davis & Co. formerly of Cincinnati, Ohio, June 18, 1878, as a trade-mark for stoves and ranges, as will more fully appear by reference to Certificate No. 6,232, of that date, and has been continuously used by said corporation applicant and those from whom it derived its title since January, 1864.

The class of merchandise to which the trade-mark is appropriated is stoves and ranges, and the particular goods comprised in such class on which it is used by said company is coal, gas, wood and oil cooking and heating stoves

15 with the word "Stoves" being inscribed upon
a representation of rays from the sun rising
above a representation of clouds, upon which
clouds is inscribed the word "Ranges," the
word "and" being located between the words
20 "Stoves" and "Ranges," and the whole being
incased within a circular border. But these
words may be omitted, and the various acces-
sories of the picture may be varied at pleas-
ure or altogether omitted without materially
25 altering the character of the said trade-mark,
the essential feature of which is the word-
symbol "FAVORITE."

ed it upon circulars, cards, labels, bill and let-
ter heads, and on advertisements relating to
or describing said articles of manufacture, 45
and also represented it upon stoves and
ranges themselves.
